FLOOD ANALYSIS USER AGREEMENT

Terms and Conditions

This agreement is entered into between the Foundation of Real Estate Associates, its contractors and data sources and suppliers (collectively "FREA"), First American Flood Data Services, its parent companies, subsidiaries, affiliates, divisions, contractors and all data sources and suppliers (collectively "FAFDS") and home inspectors ordering an analysis.

By requesting an analysis, determination, or other services from this Website, you agree to the terms and conditions set forth herein. If you do not agree with any of these terms or conditions, do not access or otherwise use this Website, the products, or any information or content contained on this Website. For purposes of these terms and conditions, the term "Analysis" includes any electronic or hardcopy manifestation of a product or service ordered through and obtained from this Website, from FREA or from FAFDS, individually or collectively, as the context requires.

RIGHTS AND RESPONSIBILITIES

You agree to submit individual street addresses to FREA via the Website for the purposes of deriving FEMA NFIP Information, as described on the Website. You shall not add the FEMA NFIP Information onto the FEMA Standard Flood Hazard Determination Form (FEMA Form 81-93), or any other regulatory document required by the federal government to be maintained as the source of flood zone information now or in the future, and are prohibited from so doing. You cannot use this data to determine if flood insurance is a requirement for a loan secured by a home. You cannot assign any rights under this Agreement to any third parties. You agree to keep confidential any information about any FREA or FAFDS processes, procedures, trade secrets, proprietary information, pricing information, source information, or any other information in these terms and conditions or in any way related to the Analysis. These "Rights and Responsibilities" are considered part of the Terms and Conditions and are not intended to be emphasized, highlighted, or hold any more significance than any other portion of the Terms and Conditions.

You certify that the information you provide to establish this account and purchase products or services through this Website is true and correct, that you are the person whose information has been submitted, that you are over eighteen (18) years of age and that you are a home inspector licensed by the State in which you practice if the state in which you practice issues licenses. If any information you provide is untrue, inaccurate or not current, or if FREA or FAFDS has reasonable grounds to suspect that such information is untrue, inaccurate or not current, FREA or FAFDS, at its sole discretion, has the right to suspend or terminate your use of the Website and any Analysis provided hereunder and refuse all current or future access and use of the Analysis or suspend or terminate any portion thereof.
